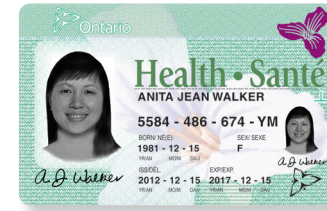


# Applying for your Ontario Health Card

Welcome to Ontario!



A resident of Ontario must have a health card to show that he or she is entitled to health care services paid for by the Ontario Health Insurance Plan (OHIP).



If you have never had an Ontario health card, you must apply for one at a ServiceOntario centre. But before you go to a centre to apply, please follow these steps:

1. Visit [ServiceOntario.ca/HealthCard](http://ServiceOntario.ca/HealthCard):
  - Print and complete the Registration for Ontario Health Coverage (form 0265-82)
  - Review the Ontario Health Coverage Document List (form 9998E-82) to see what documents are required (full list on reverse side)
2. Visit [ServiceOntario.ca/FindServices](http://ServiceOntario.ca/FindServices) to find your nearest ServiceOntario centre
3. Take the completed registration form and all required documents to a ServiceOntario centre

### Required documents

- **List 1 – Proof of Canadian Citizenship or OHIP-Eligible Immigration Status**

Documents in this list prove you are a Canadian Citizen or hold another immigration status that makes you eligible for Ontario health insurance coverage.

- **List 2 – Proof of Residency in Ontario**

Documents in this list display your name and current home address and confirm that your primary place of residence is in Ontario.

- **List 3 – Support of Identity**

Documents in this list display both your name and your signature.

Don't have a document from either List 2 or List 3? You can bring someone to ServiceOntario to vouch on your behalf. This person must live in Ontario with you, be 18 years of age or older **and** bring one of the above documents in **their** name (additional documents may be required).

**Note:** you must always have at least one document, from list 2 or 3, in your own name.

### List 1 Proof of Citizenship / OHIP-Eligible Immigration Status

CHOOSE ONE:

---

#### Canadian Citizens

- Valid Canadian Passport or Canadian Passport expired not more than five years
- Birth Certificate from a Canadian province or territory (issued under the Vital Statistics Act)
- Canadian Certificate of Registration of Birth Abroad
- Certified Statement of Live Birth from a Canadian province or territory
- Certificate of Canadian Citizenship or Certificate of Naturalization (paper document or card, not commemorative issue)
- Certificate of Indian Status (paper or plastic card)
- Registered Indian Record (certified)

#### Permanent Residents / Landed Immigrants

- Valid Permanent Resident Card or Permanent Resident card expired not more than five years
- Canadian Immigration Identification Card
- Confirmation of Permanent Residence (IMM 5292, 5688)
- Record of Landing (IMM 1000)

#### Other Immigration Status

- Letter from Immigration and Refugee Board confirming Convention Refugee or Protected Person status
- Protected Person Status document
- Temporary Resident Permit (restrictions apply)
- Work Permit (proof of full-time employment in Ontario may be required)
- Written confirmation from Citizenship and Immigration Canada that you are eligible to apply for Canadian citizenship under section 5.1 of the Citizenship Act (Canada)
- Written confirmation from Citizenship and Immigration Canada that you are eligible to apply for permanent residence in Canada
- Temporary Confirmation of Registration Document

### List 2 Proof of Residency

CHOOSE ONE:

- Valid Ontario Driver's Licence or Temporary Driver's Licence (only if accompanied by photo licence card with the same address)
- Utility bill (home telephone, cable TV, public utilities commission, hydro, gas, water)
- Monthly mailed bank account statements for savings or chequing accounts (does not include receipts, bank books, letters or automated teller receipts)
- Employer record (pay stub or letter from employer on company letterhead)
- School, college or university report card or transcript
- Child Tax Benefit Statement
- Income tax assessment (most recent)
- Insurance policy (home, tenant, auto or life)
- Mortgage, rental or lease agreement
- Ontario Motor Vehicle Permit (plate or vehicle portions)
- Property tax bill
- Statement of Direct Deposit for Ontario Works or for Ontario Disability Support Program
- Statement of Employment Insurance Benefits Paid T4E
- Statement of Old Age Security T4A (OAS) or Statement of Canada Pension Plan Benefits T4A (P)
- Statement of Registered Retirement Savings Plan (RRSP), Registered Retirement Income Fund (RRIF) or Registered Home Ownership Savings Plan (RHOSP) from a financial institution (bank, trust company, credit union)
- Workplace Safety and Insurance Board Statement of Benefits T5007
- Your Canada Pension Plan Statement of Contributions
- Valid Ontario Photo Card

- Canadian Immigration Identification Card
- Certificate of Canadian Citizenship (plastic card)

- Confirmation of Permanent Residence (IMM 5292) (only if signature is displayed)
- Current employee ID
- Current professional association licence
- Old Age Security Card
- Ontario Motor Vehicle Permit (plate portion)
- Passport (Canadian or foreign)
- Permanent Resident Card (only if signature is displayed)
- Record of Landing (IMM 1000)
- Student ID card
- Union card
